Councilmember Jim Sells: I'm very excited about Mrs. Hines comments. We are talking now talking about the budget. It's my opinion what is said is absolute fact. We are draining our resources by spending. We are draining the money we need for infrastructure and improvements for our utilities and that is doing opposite of what I believe Mr. King is talking about. We need to be fiscal responsible to attract businesses. We need our infrastructure strong and we need reserves. We are draining our reserves. You can't put enough accountants in front of me to tell me that the audit is wrong. The audit is the audit I'm hopeful and very happy Mrs. Hines is talking about the budget. And I hope all five of us are talking about the budget. It is now on the agenda. Ultimately if you prove me wrong you will get an apology but ultimately what I believe we are going to do is what we did back in 2012 and 2013. We're going to figure out where the fat is and we are going to trim it. So, we can be fiscally responsible for the people who are paying. We can stop doing forty percent water and sewer increases and forty percent property increases. Thank you for hanging in here so long.
