Adopt 2023 Planning Commission Meeting Schedule

Citizen Comments

Mr. Proctor was recognized by the Chairman and he asked if the Planning Commission had knowledge of property at a site off US Hwy 29 where a tree removal company is using property and whether or not the use conformed to zoning requirements. Mrs. Bugg stated that the occupant of the property is making loud noises during the week and weekends, possibly as a result to grinding trees at the property. Mr. Jones stated that the property owner had asked for City utilities but it was not know if the City provided access to utilities for this property. Mr. Jones stated that enforcement of zoning ordinance violations is the responsibility of Grantville code enforcement officer. Mr. Jones stated that he would contact City staff to determine if an enforcement action is being taken against the property owner as a result of a property use violation.

Mrs. Pendley of 25 Canterbury Drive was not recognized by the Chairman however, she addressed the Planning Commission expressing her opposition to approving any new subdivision in the City and asked if the planning commission conducts any impact studies related to approval of new subdivision developments. She expressed concerns about water supply for the City and suggested that rain barrels at homes should be used for water. Following a brief discussion with the Chairman, Mrs. Pendley left the meeting.

Adjournment

Mr. Ward made a motion to adjourn the meeting. Mrs. Bugg seconded the motion. Mr. Raptis adjourned the Planning Commission Meeting at 6:40 p.m.

Grantville Zoning Ordinance Proposed Text Amendment Article 17.7-2

January 5, 2023

1. Name and address of applicant.

2. Current provisions of text to be affected by amendment.

Replace the existing text:

17.7-2 Signs Posted. As to an application to amend the Official Zoning Map(s), if such application is initiated by any party other than the City Council or the City's Zoning Administrator, the Zoning Administrator (or a designee) shall post a sign in a conspicuous place on the property for which the application has been submitted at least fifteen (15) days and no more than forty-five (45) days in advance of the City Council's hearings. Said sign shall contain information as to the date, time and place of the public hearing, the current zoning classification and the proposed zoning classification.

With the following text:

17.7-2 Signs Posted. As to an application to amend the Official Zoning Map(s), if such application is initiated by any party other than the City Council or the City's Zoning Administrator, the Zoning Administrator (or a designee) shall post a sign (or signs) in a conspicuous place(s) on the property for which the application has been submitted at least fifteen (15) days and no more than forty-five (45) days in advance of the City Council's hearings. Said sign(s) shall be constructed of wood or metal, a minimum of 48 vertical inches by 72 horizontal inches in size, and with lettering of a minimum of three (3") inches in height in bold black letters on a white background, except that the existing and the proposed zoning districts shall be in red letters. The sign shall list the name of the applicant, applicant telephone number, property address, date and time of the public hearing, present zoning, proposed zoning, proposed property use, and the telephone number of Grantville Planning Department. An example of the public notice sign is shown below.

- 1. Sign(s) shall be placed within one foot of the public right-of-way along street frontage of the property at 1,000-foot intervals for which the zoning change has been requested.
- 2. If the property has 1,000 feet or less frontage, only one sign is required.

- 3. If the property has no street frontage, the sign shall be placed within one foot of the right-of-way of the street or road at each location from which access will be gained to the property.
- 4. The petitioner shall provide a plan showing the location(s) where Notice to Rezone signs will be placed on the property.
- 5.. The signs shall remain posted until final action has been taken by the Council or the application has been withdrawn.
- 6. The petitioner shall remove all "notice to rezone" signs and return the signs to the City of Grantville within 10 days after final action by Council.
